- 1. The Bidders should be registered with Pakistan Engineering Council (PEC) for the year 2024-25 in Relevant Category & field of Specialization and FBR and KPRA with active status for the Year 2024-25 and Enlisted with Khyber Pakhtunkhwa Housing Authority (KPHA) for the year 2024-25.
- 2. Biding documents including instructions to bidders and BOQ can be downloaded up to one day prior to the opening date from KPHA & KPPRA Web Site (https://www.housingkp.gov.pk/).
- 3. A complete set of Bid Solicitation Documents can be obtained at a cost of Rs.5,000/- (Non-Refundable) on submission of a written application one day prior to the opening date from the office of **Director General Khyber Pakhtunkhwa Housing Authority (KPHA) ATI Campus Opposite Islamia College Gate University Road Peshawar**, otherwise bids submitted without these documents will not be processed for post qualification.
- 4. The bidders are required to quote their rates (electronically as well as in hard form of BOQ) "ABOVE/BELOW/AT PAR" on BOQ/Engineer Estimate. Only two digits after the decimal point shall be considered for evaluation purpose.
- 5. The bidders quoting their bids more than 10% below on Engineer's Estimate shall submit an Additional Bid Security as per KPPRA Notification No. S.R.O. (14)/Vol: 1-24/2021-22, Dated May 10, 2022 at the time of bid submission. The bidders should also submit an affidavit in the technical bid stating that the Bid Security & Additional security (if any) is enclosed in the financial bids.

- 6. Tender Form Fee (non-refundable) @ 0.03% of the estimated cost in the shape of call deposit should be accompanied with technical bid.
- 7. All prevailing rules of KPPRA issued from time to time shall be observed during the procurement process.
- 8. All Bidders are required to be Registered with the Khyber Pakhtunkhwa, Revenue Authority (with active status) Established under the Khyber Pakhtunkhwa, finance act, 2013.
- 9. A Pre-bid meeting will be held in the office of the undersigned on 24-10-2024 at 11:00 AM.
- 10. The competent authority reserves the right to reject any or all the bids assigning cogent reasons.
- 11. The bidders must visit the site prior to submission of bid to be fully well versed of the site conditions.
