- 1. The Bidders should be registered with Pakistan Engineering Council (PEC) for the year 2022-23 in Relevant Category & field of Specialization and FBR and KPRA with active status for the Year 2022-23 and Enlisted with Provincial Housing Authority (PHA) for the year 2022-23.
- 2. Biding documents including instruction to bidders and BOQ can be downloaded up to one day prior to the opening date from PHA Web Site (https://www.housingkp.gov.pk/).
- 3. - 4. The bidders are required to quote their rates (electronically as well as in hard form of BoQ) "ABOVE/BELOW/AT PAR" on BOQ/Engineer Estimate. Only two digits after the decimal point shall be considered for evaluation purpose.
- 5. The bidders quoting their bids more than 10% below on Engineer's Estimate shall submit an Additional Bid Security as per KPPRA Notification No. S.R.O. (14)/Vol: 1-24/2021-22, Dated May

- 10, 2022 at the time of bid submission. The bidders should also submit an affidavit in the technical bid stating that the bid security and additional security (if any) is enclosed in the financial bids.
- 6. Tender Form Fee (non-refundable) @0.03% of the estimated cost in the shape of call deposit should be accompanied with financial bid.
- 7. All prevailing rules of KPPRA issued from time to time shall be observed during the procurement process.
- 8. All Bidders are required to be Registered with the Khyber Pakhtunkhwa, Revenue Authority (with active status) Established under the Khyber Pakhtunkhwa, finance act, 2013.
- 9. A pre-bid meeting will be held in the office of the undersigned on 03-11-2022 at 11:00 AM.
- 10. The competent authority reserves the right to reject any or all the bids assigning cogent reasons.
